Accomplishments in 2011

With thanks, we presented the Rev. Bill Somplatsky-Jarman with the William E. Gibson Lifetime Achievement Award and recognized Montview Boulevard Presbyterian Church, Denver, CO with PEC's Restoring Creation Award.

We shared a successful conference: God's Earth: Too Big to Fail? An Eco-Justice Conversation among Faith, Science and Culture, at Highlands Camp and Conference Center in Allenspark, CO, August 31 – September 3. Highlights included the excellent leadership of Rev. Dr. Bill Brown (Columbia Theological Seminary), Teyvyn East with "Leaps and Bounds", and many others. We appreciated tours of the Rockies and noteworthy environmental agencies coordinated through St. Andrew Presbyterian Church, Boulder, CO; Stan Adamson, Pastor.

We held a continuing partnership with and provided financial support for the Eco-Stewards 2011 program in Montana with twelve young adults. PEC collaborated with the Environmental Ministries Office and supported their Earth Care Congregations program.

Regional Representatives began an enhanced communications program with PEC members as well as with Presbytery and Synod eco-justice leadership through a series of e-mailed letters.

The Steering Committee welcomed Abby Mohaupt as Editor of the *PEC Update*.

We continued an excellent and appreciated partnership with the Eco-Justice Program office of the National Council of Churches as a home base for our PEC coordinator, Shantha Ready Alonso.

We greatly enhanced our communication and outreach through social networking on Facebook, Twitter, and our PEC blog.

Members prepared an Advent and Lenten Study/Devotional Series that were distributed by e-mail and through our social networks.

Goals for 2012

Expand our PEC network and membership through social media, an enhanced role for Regional Representatives, and improved communication.

Determine PEC advocacy priorities, prepare in written form, and distribute to the PEC network.

Prepare and share devotional writings such as Advent and Lenten studies.
